Dear Parent/Carer,

As you are aware, all year 11 students will be sitting a series of mock exams in December for all subjects. A full exam timetable will be issued to students within the next fortnight and we will also send this to parents. During this period, we aim to provide a situation as similar as possible to what the students will experience during their actual GCSE exams in the summer. The purpose of this is to help students to develop the skills necessary for dealing with a pressurised and often stressful environment of having multiple exams within a short time period.

It is crucially important that students prepare for these exams and we will ensure that they are doing so in lessons. We appreciate your support in also ensuring that students are working at home. They should be doing revision every evening and for a period of time at weekends as well as completing any homework set by teachers. We would recommend students devising a revision timetable to ensure that they are preparing for all subjects in equal measures.

On the school website, we have put a link to a document with a number of study skills and revision strategies for students to use during their preparation, as well as document with suggestions of how you, as parents, can also help to support your child in making the most out of their revision.


In January, students will receive the results of their mock exams in an envelope, again to re-create the feel of a results day.
